



Orla Announces Appointment of E. Morin as CFO

VANCOUVER, British Columbia, March 13, 2018 -- **Orla Mining Ltd.** (TSX-V:OLA) (the “**Company**” or “**Orla**”) is pleased to announce that Mr. Etienne Morin will be joining the executive team at Orla as Chief Financial Officer. Mr. Paul Robertson will step down as Chief Financial Officer, and Mr. Morin will assume the role effective April 30, 2018. Following Mr. Morin’s appointment, Mr. Robertson will remain active with the Company in an advisory role.

Marc Prefontaine, Chief Executive Officer of the Company, commented: “On behalf of the Board of Directors, we would like to welcome Etienne to the Orla team. Etienne has extensive industry experience and market understanding, which will help guide the Company through the next phase of its development, and I look forward to working with him to execute on the Company’s strategic initiatives. I would like to thank Paul Robertson for his dedication to this role since 2015, including his oversight of two significant acquisitions for Orla.”

Mr. Morin joins Orla from Goldcorp Inc. where he spent the last 11 years in various finance and operations roles, as well as acquiring significant capital markets experience in his roles as Director of Corporate Development and more recently heading the investor relations function. Mr. Morin holds a Bachelor of Arts in geology from Colgate University and a MBA from the Telfer School of Management at the University of Ottawa.

Orla Mining owns two advanced stage open pit, heap leach style oxide gold projects in Panama and Mexico. Camino Rojo is an advanced gold and silver project covering over 200,000 hectares in Zacatecas State, Central Mexico. The project is 100% owned and has historical oxide reserves along with historical sulphide resources (which Goldcorp Inc. retains a back-in right on the sulphides). The Company believes it has exploration potential for additional oxide and sulphide mineral resources. Access and infrastructure are excellent with a paved highway and powerline nearby. A NI 43-101 Technical Report dated January 24, 2018, on Camino Rojo is available on SEDAR. The 100% owned Cerro Quema project in Panama includes a near-term gold production scenario and exploration upside. Cerro Quema’s 14,800 Ha concession boasts paved road access, a supportive local population and private land ownership. The Cerro Quema project is currently in the last stage of the permitting process for a proposed open pit mine and gold heap leach operation.
